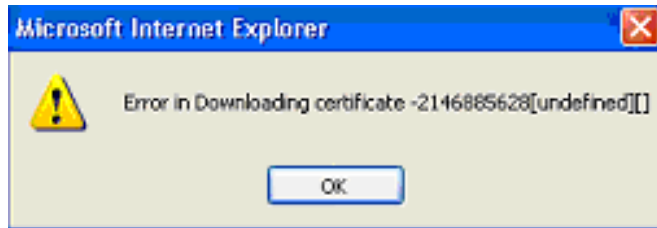
ABOUT THE DOCUMENT

This document describes the procedure for applying Certificate Replacement.

GETTING STARTED

The Certificate Replacement is available when any of the following error occurs.

1. Certificate is not downloaded.



2. Certificate is downloaded but not exportable from browser (private Key is not exportable) after download.



If any of the above errors occurs during downloading of the Digital certificate then inform your Registration Authority and follow steps as given below to get the certificate replacement.

The certificate replacement option is available only for 5 calendar days from the date of issuance of Digital Signature Certificate. After 5 calendar days certificate replacement option will not be displayed. Please inform immediately to your RA and start the process of certificate replacement when you get the above errors while downloading.

Please note: The subscriber can avail the certificate replacement only ONCE

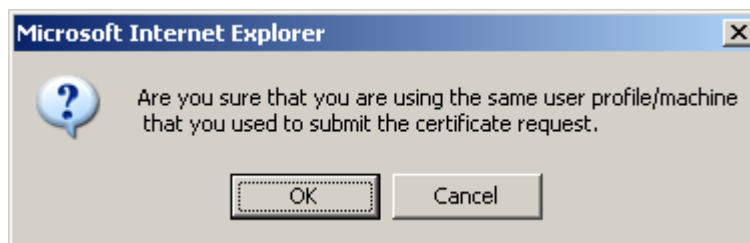
STEPS TO BE FOLLOWED TO GET CERTIFICATE REPLACEMENT:

- Go to your Registration Authority Website and Login as member.
- Click on **click here** link in 'Step-4' section.
- Click Request Number. There will a button "Replace"

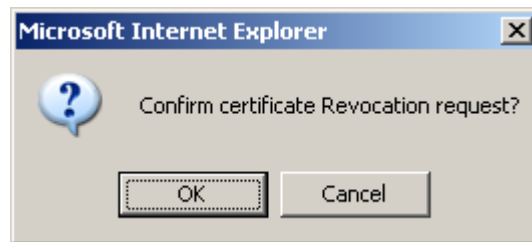

- Click on button "Replace". It will open page to revoke the certificate.

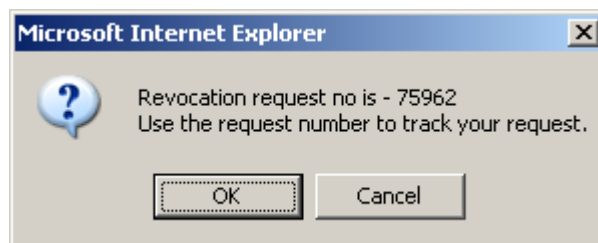
- Specify the reason based on the error (Certificate is not downloaded/ Private key is not exportable) and click on button "Revoke".

- For Safenet iKey 2032 32k please select " Datakey RSA CSP"
